Dear Mr. Xennt:

This letter will serve to terminate your authority as provided by me to you and the Public-Root Ltd. on November 19, 2004. All rights and notices of a right to you or the Public-Root Ltd. is hereby revoked. I am taking this action based on the facts presented to me that you are a fraud and as such have no right to represent a valuable public trust like the Public-Root.

- You have committed forgery with respect to Mr. Thornton's resignation from Council.
- You have embezzled funds from the Public-Root organization with the help and assistance of Marcel Bor at UNIDT. You have also committed tax fraud with the assistance of Marcel Bor using Public-Root funds.
