INFORMAL STATEMENT OF JOE BAPTISTA TO HOOFDINSPECTEUR ANDRE VAN REES OF THE GOES POLICE AND THE POLICE OF THE NETHERLANDS CONCERNING THE BUNKER IN GOES ZEELAND FORMERLY ASSOCIATED WITH AN XTC LABORATORY.

Dear hoofdinspecteur Andre van Rees:

I believe I have made your acquaintance about a month ago when you were at the Bunker ([www.cyberbunker.com](http://www.cyberbunker.com)) in Goes the former site of an XTC laboratory. You will remember I told you I was investigating the creation of the commercial Internet at that facility. Since our meeting I have completed my investigation and am prepared to share the information with you.

I have also spoken to and will also be sharing this information with Bernhard Stellrecht the Kriminaloberkommissar of the Polizeiprasidium Sudhessen in Heppenheim Germany.

I will provide you here with information that you must verify on your own as I do not intend to share all of my sources, many of whom are diplomatic service officers who are personal acquaintances. I anticipate your police service will have most of these details on file and I expect you to verify the details independently of my claims.

First I would like to formerly introduce myself. I am one of the founders and creators of the Public-Root system that defines the principles of shared interoperability in the operation and administration of the Internet. The Public-Root replaces the former Internet experimental DNS (Domain Name Systems) that was developed and designed by the United States Government under DARPA the Defense Advance Research Projects Agency.

I consented this past year to allow one Herman Johannes Xennt ([www.xennt.com](http://www.xennt.com)) to setup a public-root system. Mr. Xennt was very successful in setting up a number of organizations to promote the public-root. He also to my amazement was able to get the Turkish government involved in the operation and the Public-Root now operates the DNS in turkey under the authority of the Turkish government.

My investigation has uncovered fraud, tax evasion, and connections to organized crime, namely an association to the Irish Republican Army (IRA) through an individual who goes by the name Mr. George Green. Mr. Green has no fixed address but lives out of hotels in the greater Amsterdam area. Mr. Green passes himself off as an international businessman.

At this time the Turks have suffered considerable embarrassment due to the

unprofessional actions of Mr. Xennt and his association with fraud and organized crime. Dr. Mehmet Altuner a council member with INAIC ([www.inaic.com](http://www.inaic.com)) and the head of the Turkish Telecommunications Authority has resigned from the project.

All of the INAIC council members have likewise resigned except for Mr. Scheepers and Mr. Dawe. Mr. Scheepers and Mr. Xennt have refused to remove the names of the resigned council members from the web site. I see liability here as good people get slimed with Mr. Xennt association with fraud and organized crime. I would ask that you ensure their names are immediately removed. I will be asking the Turkish authorities to also investigate this, as I am not sure if of the involvement of Turkish officials in this mess. TLDs can be used to launder money and it is my intention to ensure the involvement of the Turkish government is clean.

I also want to report that my life was threatened by one Marcel Bor a resident of Harlem and an associate of Mr. Green. I have reported the treat to the Canadian Embassy in The Hague where I have registered. This information was also reported to the Canadian Embassy in Berlin.

As you know the Bunker was the subject of a fire several years ago. A number of people were arrested as a result of the incident when it was found that an XTC lab existed in one of the underground rooms. This included one Herman Johannes Xennt (also an associate of Mr. Green) who was incarcerated for a period of 5 months shortly after the raid.

Ms. Rheanti Retnasari ([www.rheanti.nl.vg](http://www.rheanti.nl.vg)) the responsible party for the not for profit foundation called Wasteland that owns the bunker was also arrested. Ms. Retnasari is a native of Indonesia and the girl friend of Herman Johannes Xennt.

Mr. Xennt and the others were released and found not guilty of the crime when three people confessed to it.

Three Chinese individuals were arrested for their involvement in this affair. But I suspect their confession to running the XTC lab was bogus and that they were not involved with it. I believe their confession was a setup and convenience to allow the guilty parties to go free.

I further suspect the lab was setup to finance banking operations under the control of Herman Xennt and Marcel Bor and that the individuals responsible for the labs operation and maintenance were Herman Johannes Xennt, Marcel Bor and finally George Green. I suggest you open this file and investigate further.

The bank the XTC lab was to finance is called Bank66.com.

I arrived in the Netherlands this July 16, 2005 to begin my investigation and lived most of the time in the Bunker where a room was made available to me to work and sleep.

I believe we met shortly after my arrival when you and a number of civic officials from Goes City Hall and two fire inspectors came to the bunker to investigate compliance with local zoning by-laws. I think you were also looking for illegal workers who were at the time of your visit hidden in secret locations in the bunker so as to avoid detection by you.

During my investigation it came to my attention that even though the Public-Root was making money through it.s contract with UNIDT ([www.unidt.com](http://www.unidt.com)), an organization located in Amsterdam the people working for the Public-Root ([www.public-root.com](http://www.public-root.com)) were not being paid. It further came to my attention that the Public-Root at that time did not have a bank account.

Herman Johannes Xennt kept claiming to the people involved in the operation that there was no money. The truth is Herman Xennt and Marcel Bor an employee of UNIDT were moving money around to different bank accounts not related to the Public-Root and that these bank accounts were being used by Mr. Xennt and Mr. Bor to enrich themselves and avoid taxation by the local authorities.

In a few instances Ms. Retnasari.s bank account has been used to receive deposits from UNIDT on behalf of the Public-Root and those deposits were then cashed and the money distributed to Xennt and Bor.

It should also be noted that Mr. Green has a secretary by the name of Khadija Bouchiba who works from time to time and has an email account at UNIDT.

Your local tax authorities should have on file information that shows Xennt and Bor have been in trouble with the local tax authorities before with respect to schemes intended to avoid taxation. In the case of Mr. Xennt he had a company known as SYSTIM (?) which defrauded the local tax department of some one million guilders.

Mr. Xennt and a friend and business associate by the name of Paul Scheepers were found guilty of a taxation crime a few years ago and now owe the local tax authorities a total of one million guilders.

The same nonsense was being practiced using the Public-Root as a vehicle to avoid taxation. Mr. Scheepers is again involved with Mr. Xennt. Mr. Scheepers is the director of the Public-Root Ltd., a company incorporated and registered in the United Kingdom.

During my investigation I spoke with a Mr. Martijn Burger who is the chairman of INAIC and a director of the Public-Root (BV) a company incorporated in the Netherlands which held the shares of Public-Root (UK) Ltd. Mr. Burger provided me with inside information of the corporate associations that were hidden from those people who invested their time and money into this mess.

According to Mr. Burger the Public-Root a company in the UK at the time was owned by the Public-Root BV a company in the Netherlands, the Netherlands BV shares were in turn held by a group of Amsterdam tax lawyers on behalf of a Cyprus company. A Panama lawyer that holds the shares in trust on behalf of a group of unknown shareholders in the Cyprus company.

This organizational structure was discontinued on August 15 when I ordered Mr. Burger to transfer the shares of Public-Root (UK) Ltd to INAIC (The Internet Names Authorization & Information Center) a Stichting and Vereniging established in the Netherlands. This was done to bring the organizational structure into compliance with statements made by Mr. Xennt to Mr. Jody Newman a lawyer for UNIDT.

The purpose of this complicated structure was to avoid taxation and launder money. My intervention prevented any further fraud from being perpetuated by Herman Xennt and Marcel Bor.

I request that you provide this information to your local tax authorities so they may investigate further. You should secure the payment records and bank accounts of UNIDT to see exactly how the moneys were transferred and to what accounts they were paid.

I also want to advise you that during the time period that I have been in Germany Mr. Scheepers made a number of accusations against me. Namely that my luggage which was returned to Mr. Burger under the custody of an individual by the name of Sven Olaf Kamphuis (also arrested during the XTC lab incident) contained heroin. Mr. Scheepers has withdrawn this allegation and apologized to me.

However, I do not trust these people and fear my luggage may be compromised. Please secure my luggage and check it carefully for any drugs. You will find attached to this communication and statement two emails from Mr. Scheepers indexed as appendix A (in which he claims the luggage contains heroin) and another email indexed as appendix B in which he admits the claim was false and apologizes to me for those claims.

As we all know, Public-Root is a democratic organization. About one month ago, Joe Babtista came to the Netherlands, and he did not agree with the structure of our organization. The alternative proposed by Joe was not bad, however in stead of debating this in a normal and civilized way, Joe stole a bike and left the Public-Root offices on August the 14th. Since Joe left the office, Joe has officially nothing to do with Public-Root anymore.

I can also assure you that Public-Root did not gave Joe permission to send any of these confusing messages to anyone. More stronger, Joe is violating a Non Disclosure Agreement that he previously signed with Martijn Burger, the chairman of the INAIC.

We feel very sorry for Joe. It seems that Joe will do anything to get Public-Root down.
